### **Eligibility for Nomination:**

To be nominated, you must obtain virtual nominations from at least **20 eligible members** of Scarborough Campus Community Radio. DJ Representatives require 10 nominations. Eligible members include:

- Full-time UTSC students
- Community members who pay annual membership fees
- FOR DJ REP ONLY: Radio FWD DJs/Producers/Podcast Hosts

It is **recommended** that candidates obtain extra nominations in case some are ineligible.

### **Important Dates:**

- Nomination Deadline: February 17, 2025, by 11:59 PM (via email to sccrcro@gmail.com)
- Late Submission Deadline (with CRO approval): March 3, 2025
  - Late submissions require a written explanation and CRO approval.
  - Candidates have up until the day before elections to submit their nominations.
- Candidate Information Session: Scheduled based on candidate availability
- Campaign Period: 2 weeks from approval (late nominations forego any missed campaign period)

- A \$10 deposit is typically required but has been waived for the 2025 Elections
- Deposits (if applicable in future elections) can be submitted:
